

# Terms & Conditions

## Registration

- All parents/carers must complete our Registration Form before a child can be accepted at any AW Cool Kidz provision through AW Coaching. Registration must be done directly on our website [WWW.AWCOACHINGACADEMY.COM](http://WWW.AWCOACHINGACADEMY.COM)
- By registering, the parent/carer gives AW Cool Kidz/AW Coaching permission to take your child/children off site – this may be for the purpose of, but not limited to, walking to village hut or village field.
- AW Cool Kidz/AW Coaching must be notified of any changes in Registration details, as soon as possible, in writing by the parent /carer. This can be made by letter or email to [aw\\_coaching1@hotmail.com](mailto:aw_coaching1@hotmail.com)

## Booking Sessions

- All sessions requested by parents/carers are subject to availability.
- All sessions booked must be paid for in advance.
- No parent/carer should consider a booking as being accepted until payment has been received by AW Cool Kidz/AW Coaching.
- Bookings may be made on the day before the start of any session. We will accept emergency bookings if parents are going to be late.
- AW Cool Kidz/AW Coaching will credit all fees charged if the club is forced to close due to unforeseen circumstances.

## Responsibility for attendance

- It is the parent/carer's responsibility to ensure that their child/children arrive, on time, to any breakfast or Holiday Club, and are signed in accordingly.
- It is the parent/carer's responsibility to ensure that their child/children are aware that they will be attending any After-School Club.

- It is the parent/carer's responsibility to notify AW Cool Kidz/AW Coaching if there are late changes made to their child/children's club attendance on that day, this can be made by email or phone call, but booking is essential.

### **Penalties for Late Collection**

- It is the responsibility of all parents/carers collecting children to do so promptly at the end of the session. Failure to do so will expose the parent/carer to the payment of a financial penalty and will constitute a breach of the terms and conditions, entitling AW Cool Kidz/AW Coaching to exclude the child from subsequent sessions.

### **Responsibility for Payment**

- The responsibility for payment of all fees, charges and penalties lies at all times with the person who has made the booking.
- Failure by AW Cool Kidz/AW Coaching to make a written or verbal request for payment of fees does not constitute an excuse or reason for late, or non-payment under any circumstances.
- Failure to settle all fees and/or penalties when due may result in the club taking action (including legal action) to recover any outstanding sums.

### **Childcare Vouchers**

- It is the parent/carer's responsibility to ensure AW coaching are updated with childcare vouchers.

### **Legal: Waivers, Exclusions and Jurisdiction**

- These terms and conditions are governed by English law and subject to the jurisdiction of the courts of England and Wales.
- AW Cool Kidz/AW Coaching shall not be liable for any direct or indirect loss suffered by parents/carers as a result of club closures under the terms of the agreement, including but not limited to loss of profits, increased costs or expenses or wasted expenditure.
